#### **FOREWORD**

#### **COLLEGE PROFILE**

Ewing Christian College was founded in the year 1902. The first Principal was Dr. Arthur H. Ewing. The College Campus is located on the Northern Bank of Jamuna River about 3 Kms. away from Sangam and about 4 Kms. from the Railway Station. The College is a Christian Minority Educational Institution, managed by the Ewing Christian College Society, consisting of the Bishop of Lucknow Diocese of the Church of North India and other Indian Christian representatives.

Since 1994 Ewing Christian College is an autonomous constituent college of the University of Allahabad. The University Grants Commission (UGC) and the University of Allahabad, under the UGC Scheme of Autonomous Colleges have allowed the College to formulate its own courses of studies and evaluate its own students separately. The Degree is awarded by the University of Allahabad at U.G. and P.G. level.

Several self-financed vocational courses namely –Electronics, Computer Application, Biotechnology, Microbiology, Biophysics, Physical Education, B. Com. & BCA have been permitted to be run as Degree Programs of the Allahabad University. Several Diploma programs and some compulsory Certificate Programs are also running to impart technical skills to students. The timings of these programs are such so as to enable students of the College to enroll themselves without missing their classes.

Regular attendance (75%) in the class room has been made compulsory and Semester System of teaching and evaluation has been introduced in the College since the academic session 2014-15, based on Choice-Based Credit System (CBCS). Entire College programs, thus, have been oriented towards maintaining high academic standards, acquisition of knowledge, skills and scientific temper rather than merely passing the examinations for a degree. The medium of instruction is mostly English in Science. Teaching in Arts Faculty is done both in English and Hindi.

The large eco-friendly campus, well-equipped laboratories, libraries, prolific gardens, daily Chapel services, games and sports, NCC and NSS and a host of other extra-curricular activities encourage students to develop a spirit of enquiry and enrich their lives meaningfully. A modern Gymnasium, Women Cell with counseling as one of its activities, Student Union and Cafeteria etc. provide excellent Student Support Services. A Branch of Canara Bank is also present in the College Campus.

It is expected that students, seeking admission in this College will take admission, if selected, fully aware of its Minority and Autonomous Status, and will be more interested in acquiring knowledge and skills by regularly attending classes rather than passing the examinations for a Bachelor's or P.G. Degree.

#### **Department of Botany**

Dr. Winfield Dudgeon, an American missionary and renowned botanist (1912–1922), founded the Department of Botany at Ewing Christian College. In 1919, he was appointed the founding president of the Indian Botanical Society, a recognition of his exceptional expertise. Under his leadership, the department produced many outstanding students who went on to make significant contributions in both academia and various other fields. In 2006-07, the Department of Botany was recognized as one of the Star Departments of the College under its Centre for Potential status.

The department began offering a Master of Science (M.Sc.) in Botany in 2016, followed by a Doctoral (Ph.D.) program in 2019. Both programs have been designed with an updated, dynamic curriculum, ensuring the department's continuous progress. The department offers postgraduate specializations in Applied Molecular Cytogenetics, Applied Microbiology, Plant Ecology, Plant Biotechnology and the **Taxonomy of Angiosperms**.

Students from the department have consistently excelled in competitive exams such as CSIR, GATE, CUET, and other job-oriented exams. There has been a steady increase in students qualifying for prestigious exams like CSIR-JRF NET, SLET, GATE, and state-level TGT and PGT Biological Science/Botany exams. The faculty and research scholars of the department regularly publish research papers in well-regarded national and international journals, known for their high impact factors and extensive citations. This underscores the departments' dedication to advancing botanical research and making significant contributions to the global scientific community.

The department also encourages active student participation in extracurricular activities, organizing events like botanical excursions, the Lacy Memorial Botanical event, lectures from distinguished professors and scientists, seminars, and workshops. These activities not only enhance students' academic experience but also help foster a well-rounded educational environment.

Department established Centre for Biotechnology and Centre for Microbiology from academic session 2016-17 for strengthening of Biological Sciences and Biotechnology education and training at Under graduation and graduation level. Professor Panchanan Maheshwari, (D.Sc., FRS); Professor U N. Chatterjee (D.Sc., FNASc.): Dr. N. L.Pai (D.Sc., FNASc) Professor J. S. Singh (FNA, FNASc., FASc.) have been alumni of this Department. The department has well-furnished lecture theatres, laboratories, library and research labs.

#### **Centre for Biotechnology**

The Centre for Biotechnology was established in 2016 in the Department of Botany.

The Centre has undergraduate courses with a combination of Botany and Chemistry, with 40 sanctioned seats.

The Centre for Biotechnology focuses on empowering the students with the knowledge, skills and trains them in various advanced disciplines of Biotechnology such as Molecular Biology, Genetics, Biochemistry, Immunology, Tissue Culture Techniques, Environmental and Industrial Biotechnology, Microbiology, Recombinant DNA Technology, NanoBiotechnology, Pharmaceutical, Animal Biotechnology and Bioinformatics. This approach nurtures the budding intellects to meet futuristic challenges and develop global competencies in the field of Basic and Applied Biological Sciences.

The Centre is well equipped with spacious, well ventilated and smart lecture rooms, Library with well-curated collected of Books and state-of-the art laboratory facilities.

We stand at the intersection of Biology and Technology, to unlock the potential of living systems for the benefit of overall societal and environmental ramifications of biotechnological applications, adhering to ethical behavior in both professional and research settings.

To transform passive learning into active engagement and making education more meaningful and impactful, students are engaged in project works, which makes them explore complex research areas that are difficult to design and perform in wet lab. It offers several benefits to the students, including enhancing analytical and critical thinking skills, developing strong research and writing abilities, oral presentations, and using visual aids to successfully convey

scientific concepts, experimental results, and research conclusions to audiences that are both scientific and non-scientific.

With the strong emphasis on research, hands – on learning, and overall development of the personality of the student, the department, regularly organizes seminar, training, educational visits, Guest Lectures, competitions etc., that is very important in current scenario.

The curriculum and syllabus is well framed, keeping in mind, the demand of this upcoming and emerging field of biotechnology, so that the students are competitive enough to confidently take up the prestigious exams like IIT JAM, GAT-B, BHU, AIIMS, JNCASR, , JGEEBILS, CUET PG, Delhi Technical University and various private universities and educational centers. This remarkable approach has resulted in increase in the number of qualifying students, every year, and getting enrolled in the prestigious educational centers across India like IIT, AIIMS, MKU, Central University of Punjab, University of Allahabad, BHU, CSIR Labs, Punjab University, centre for DNA Fingerprinting and Diagnostics-Neuro Science and Cell Biology, CSIR-CDRI, JNCASR, Rajiv Gandhi Centre for Biotechnology, IISc Bangalore etc.

The Department is proud to have a diverse and highly qualified team of faculty members with PhD, M. Tech, CSIR NET qualification, passionate about teaching, research and innovations, bringing a wealth of expertise from various domains of Biotechnology.

#### **Centre for Microbiology**

The Centre for Microbiology was established in the Department of Botany during academic session 2016 - 17 with the aim to appraise the students in this applied field of science. It intends to utilize the microbes for sustainable solutions to several global issues, deliver expert microbiological diagnostic services to the public and promote research and development activities in the emerging area of microbiology. Presently Microbiology is running as one of the subject combination in B.Sc. along with Zoology and Botany (BMBZ). The centre is equipped with sufficient laboratory facilities and a well-stocked library, facilitating hands-on learning, innovative research, and skill development. The faculty members are well qualified with profound experience and stay abreast of the latest scientific advancements in microbial biochemistry, genetics, molecular biology, clinical microbiology, and other emerging fields, mentoring students in practical skills and research methodologies. Presently seven batches of students have successfully completed the course and have enrolled in various academic courses in esteemed universities of the country.

#### **Department of Chemistry**

Established in 1902 under the visionary leadership of Prof. Prabhu Das, the Department of Chemistry has witnessed remarkable growth in both infrastructure and academic pursuits over the years. Today, the department is headed by Prof. Sharda Sundaram Sanjay and comprises eight full-time faculty members, four guest lecturers, and two laboratory assistants.

In recognition of its academic excellence, the Department of Chemistry was designated as one of the "Star Departments" under the College with Potential for Excellence (CPE) scheme in 2006–07. This prestigious status facilitated significant upgrades to the department's infrastructure, including the establishment of a dedicated Research Wing and an Instrumentation Laboratory. The department also maintains a dedicated library for its postgraduate students, housing a collection of 750 books to support their academic and research needs. Additionally, it enabled the modernization of undergraduate and postgraduate chemical laboratories, as well as all four lecture theatres. These advancements have positioned the department to offer a Ph.D. programme, further strengthening its research credentials.

The department prides itself on maintaining a high standard of classroom teaching, which remains a cornerstone of its educational philosophy. In response to the evolving global landscape and the increasing importance of research, the department has proactively integrated research-oriented activities into its academic framework.

Currently, 14 research scholars are enrolled under the mentorship of the department's highly qualified faculty, contributing to numerous publications in SCI-indexed journals. The department serves around 1,000 students, including approximately 200 from the third year of the B.Sc. programme. To support hands-on learning, the department houses three state-of-the-art chemical laboratories for undergraduate students.

Additionally, a dedicated spectroscopy lab is equipped with advanced instruments, including a Fourier Transform Infrared (FT-IR) Spectrophotometer, UV-Visible Spectrophotometer, and Flame Photometer, ensuring that students gain practical experience with modern analytical techniques.

To foster holistic development and scientific curiosity, the department regularly organizes a variety of academic and co-curricular activities, including:

Department regularly organizes various activities including Ewing lecture series and competitions under the aegis of Physics society. Indian Association of Physics Teachers (IAPT) has selected the department as a centre for prestigious National Graduate Physics Examination (NGPE). The department has made a remarkable progress on academic and related fronts.

#### Centre for Biophysics and Bioinformatics

Centre for Biophysics & Bioinformatics is an interdisciplinary centre which implements an extensive multidisciplinary education to strengthen students' employability in accordance with global standards.

#### **Center for Computer Application**

This centre was established on 5th August, 1996 as a centre of excellence in the field of computer education. The centre offers a specialized B.Sc. programme combined with Physics and Mathematics (PCAM) with a focus on core areas such as digital computing, software development, e-learning, hardware maintenance, software project management and research. The Centre has facilitated the students with latest training techniques and tools. Lecture theatres are equipped with multimedia projectors and smart boards. Software laboratories are equipped with latest desktop PCs and multimedia projectors. Two software labs and one computer hardware lab facilitate the students to learn on a hasslefree environment. All the systems are supported with online UPSs.

The faculty members are well qualified with profound experience and stay abreast of the latest computing technologies and research. They regularly mentor the students in practical skills and research methodologies. A departmental library is also functioning for fulfilling the knowledge requirements of computer science students. It is well-stocked having more than 2500 books on various computing subjects. The centre regularly organizes seminars, guest lectures, and co-curricular activities to enhance student learning and engagement.

#### **Department of Electronics**

Centre for Electronics started in session 1994-95 in Physics building with teaching of 'Electronic Equipment Maintenance' as vocational subject under the leadership of Dr. K. P. Tewari. Dr. Awadhesh Kumar Singh, who was associated from the very beginning of the course, took charge as coordinator in 1996. Several academic & infrastructural upgrades have taken place and the present subject title is 'Electronics'. This is one of the subjects in B.Sc. PEM (Physics, Electronics, and Mathematics) stream. Presently the Coordinator of center for electronics is Prof. A.K. Pathak & the Incharge of center for electronics is Mr. S.K. Chirra.

The course is based on strong theoretical and practical coursework with emphasis on application and practical training which leads the students in the following fields/areas (Thrust Areas):

- a) Fundamentals of Electronics
- b) Chip Designing
- c) Communication
- d) Networking
- e) Robotics
- f) Automatic Control System
- g) Radio Frequency
- h) Antenna Design

#### **Department of Mathematics**

Mathematics teaching at Ewing Christian College traces its roots back to 1950 when it began at the graduate level under the headship of Prof. S. Bose, alongside with specialization Physics, Chemistry, and Mathematics (PCM). In 1970, the department expanded its offerings with specializations in Physics, Statistics, Mathematics (PSM) and Economics, Statistics, Mathematics (ESM) at the graduation level. Upon attaining autonomy in 1994, two self-financed programs, Physics, Electronics, Mathematics (PEM) and Physics, Computer Application, Mathematics (PCAM), were introduced in 1995-1996.

The transition to the Semester System for all undergraduate programs took place in 2014, followed by the implementation of the Choice Based Credit System (CBCS) from the 2016-17 academic session. In 2016, postgraduate teaching commenced under the CBCS System, and a new self-financed program at the undergraduate level specializing in Physics, Biophysics, and Mathematics was introduced. The department is now gearing up to launch a Doctoral Programme in Mathematics in the near future.

#### **Department of Statistics**

**The Department of Statistics** traces its origins to July 1970, when Statistics was introduced under the Department of Mathematics, guided by Prof. Jacob Masih. A year later, the arrival of Prof. I.D. Dhariyal—later affiliated with IIT Kanpur—led to the department being renamed the *Department of Mathematics and Statistics*. Over time, renowned scholars like Prof. S.K. Bhargava (RBI, 1976), Prof. B.K. Taneja (USA, 1978), Prof. Amitabh Lal Das (Retd. I.A.S.), and Prof. Kuldeep Kumar (Bond University, Australia) contributed to its growth.

On May 5, 2001, the *Department of Statistics* became an independent entity under Dr. Santosh Kumar (retired 2018) and Dr. Randhir Singh (retired 2024). Since then, it has focused on academic excellence in statistical education and research, supported by a strong curriculum and impactful contributions from faculty and alumni.

If more than one category has been mentioned, the candidate will be considered under the general category even though supporting certificate has been attached. Candidates can claim advantage under only one category.

If the applicant does not come under the categories 02 – 07, he/she should write "General" (01) in the category box.

#### **CATEGORIES:**

- **01.** General: All applicants except those claiming privilege under categories 02 to 07.
- **O2.** Church Sponsored: All candidates who are baptized and are bonafide members of a Church shall be considered as Christian and as such Church sponsored candidates. Church sponsored candidates will be admitted in the College, irrespective of the merit earned by them in the entrance test / CUET 2025 score and the year of passing intermediate/qualifying examination, provided they appear in the entrance test and score minimum marks/fill the admission form within the stipulated date. Employees' Ward: Son, daughter, real brother/sister, husband, wife of Ewing Christian College Staff and those of ex-staff members, who have put in at least 5 years of continuous service in the College will be admitted irrespective of the merit earned in the entrance test and year of passing of Intermediate/qualifying examination, provided they have appeared in the test and have scored certain minimum marks. #### The following Sports/Games will be considered under Sports Quota:

- All Sports and Games included in the All India Inter-University Sports and Games Competition Calendar.
- Candidates claiming admission under Sports and Games category must upload attested photocopies of their highest sports/game merit certificates of the last 3 years with the application form available on the College Website during admission.
- Candidates applying under Sports and Games Category will be called for an interview for verification of their

#### **DIPLOMA COURSE**

#### **DIPLOMA IN LABORATORY TECHNOLOGY (DLT):**

It is a self-financed skill development course and open to the regular students of the College as well as students from other institution, who want to acquire knowledge and skill in Laboratory Technology. Classes are held in the evening to enable the students to take advantage of this Diploma program. The admission is done on the basis of merit earned in the Entrance test.

This Diploma program has been planned with the aim of training students in the field of Laboratory Technology for employment in various research laboratories, pharmaceutical companies, companies making diagnostic kits, nursing homes, hospitals, clinic, pathology and forensic laboratories etc. and develops entrepreneurship skills.

#### Course Outline of the Diploma Program:

The 2 years Diploma course is divided in two Halves. Mid Term Examination will be held at the middle of course.

Contents: 1. General Skills

- 2. Laboratory Instruments
- 3. Human Anatomy
- 4. Human Physiology

- 5. Biochemistry
- 6. Pathology & Microbiology

An attendance of 75% is compulsory to appear in the annual examination. In special circumstance it is permissible up to 60%.

- ✓ Marks obtained in supplementary examination will not be considered for the merit position.
- ✓ It may be noted that supplementary examination is only for those students who fail in one or more theory paper and practical examinations and not for improvement of marks.
- ✓ If candidate fails in supplementary examination, he/she will be allowed to reappear the following year in final examination.

#### Award of Diploma:

After successful completion of the programme, which includes compulsory apprenticeship of minimum one and a half month recognized scientific laboratories, pharmaceutical companies, hospitals, nursing homes or pathology centres, the student will be awarded diploma in 'Laboratories Technology' under the seal of Ewing Christian College Allahabad. A provisional certificate may be issued after the declaration of the results. Certificate for general awareness in Computer Application and Spoken English and Personality Development are also given along with the diploma certificate. Students who secure First, Second and Third position and obtain highest marks in practicals and highest percentage of attendance will be awarded certificate of honor etc.

#### **Job Opportunities:**

Diploma holders of this program have multiple employment opportunities in research and analytical laboratories, pharmaceutical companies, hospitals, dispensaries, clinics, nursing homes, etc. according to their hard work and cultivated skills. This diploma program is not recognized by U.P Medical Council or any other agencies. However, College, being Autonomous is authorized by the U.G.C. to run such diploma program. A government medical job may or may not be possible. Students after this program have better chances to get admission in higher technical institutions as well.

#### **APPLICATION AND FORM FILLING:** Online only

#### **NUMBER OF SEATS:**

The seats distribution fixed for different streams are as follows: (A) Arts: 45 (B) Science: 40 (C) Commerce: 15

College reserves right to fill vacant seats, if left, in any stream by admitting applicants from the other two streams.

#### Note:

- a) 50 % seats are reserved for Christian Minority candidates.
- b) All seats will be filled strictly on the basis of merit of Entrance Test including privilege marks.
- c) Apart from the above there is no Management or NRI seat.

#### **ELIGIBILITY CRITERIA FOR CHRISTIAN CANDIDATES:**

Christian candidates are also required to fulfill the Eligibility Criteria and go through the Entrance Test to get admission against reserved seats. They will also be required to go through a Special test on Biblical Knowledge which will be one of the factors needed to qualify for Admission against reserved seats. Such Candidates must enclose the following:

Church Sponsored Letter issued by the Presbyter In-charge of the Church stating that the Candidate and his or her Parents are permanent members in good standing, the Name, Address and Denomination of the recognized Church they belong to countersigned by the Bishop of the Diocese and a Photocopy of Baptism Certificate.

#### **DURATION:**

The B.Ed. programme shall be of duration of Two Academic Years (two semesters in each year and overall four semesters), which can be completed in a maximum of three years from the date of admission to the programme.

#### **WORKING DAYS:**

There shall be at least two hundred working days each year exclusive of the period of examination and admission. The minimum attendance of student-teacher shall have to be 80% for all course work and practicum, and 90% for school

internship, failing which the candidate will not be eligible to appear for the end semester examination i.e. theory and practical inclusive.

Students under training will not be allowed to join any institution for job during the tenure of the course. Special cases may be considered only after discussion with authorities and that too in Semester- IV only.
