7. **Proposal of modified syllabus :** Dr. S. K. Mishra, Coordinator, proposed the modified syllabus of B. Sc. Biotechnology drafted by him in consultation with faculty members of Biotechnology and experts for the approval of BoS w.e.f Academic session 2020-21

- b. **Semester 2:** **Paper 1 title changed from Bioenergetics and Human Physiology to Human Biology** (Unit 1 of bioenergetics is transferred to paper 2 of semester IV entitled Biochemistry and it was replaced by Unit 1 of paper 3 of semester V entitled Essentials of Animal Sciences); inter unit reorganization have been made in Paper 2 entitled Cell and inheritance biology

- g. **Semester 6: Elective paper 3A entitled Essentials of Animal Sciences was replaced by paper 3B entitled** Entrepreneurship and Nanobiotechnology by changing title as Bioinformatics and Nanobiotechnology . The relevant contents of Essential of animal Sciences were placed under paper 1 of Semester 2.






