NOTICE REGARDING RE-REGISTRATION & ADMISSION OF EX-STUDENTS OF SEMESTER – I OF SESSION 2025-2026


All the students of **B.A., B.Sc. & B.Com. Semester I-II of Academic Session 2024-25, who have failed in Semester Examination of Session 2024-25**, are hereby advised to note the following:

1. To ensure smooth implementation of the NEP-2020 framework, and considering that no separate examinations shall be conducted for the Ex-students of first semester of Undergraduate Programmes during the Academic Session 2025-26, **the students of Academic Session 2024-25 who have failed in the Semester Examination of Session 2024-25 are required to re-register and take admission as Ex-students under the NEP-2020 curriculum and pursue their studies in the same manner as the regular students in Academic Session 2025-2026, with the status of “Ex-Student”.**
2. For this purpose, the concerned candidates are required to complete the following re-registration & admission process **between 04.10.2025 (01:00 PM) to 13.10.2025 (11:59 PM)** to avoid any inconvenience. A penalty of Rs. 500/- will have to be paid after the last date:
 - a. Login to the ECC Student Portal on www.eccprayagraj.org
 - b. Proceed to the fee payment section where relevant choices shall be made as under:
 - In case of **B.A./B.Sc.**, out of the three subjects originally chosen by the students in the Session 2024-2025, each student shall choose any **two subjects as their Major subjects** and **one subject as their Minor subject**.

***Note:** The subject chosen earlier cannot be changed. Please note that **Biotechnology, Microbiology and Computer Application** cannot be chosen as Minor subject.*

 - In case of **B.Com.**, there is no selection of Major or Minor Paper.
 - Additionally, all students must choose **any one Ability Enhancement Course (AEC) per semester** from the list of AEC's available for selection.
3. Such **Ex-students** shall be required to attend **all regular classes**, appear in the **Internal Assessment Tests** and appear in all **theory and practical examinations of the Session 2025-2026**, as applicable under the NEP-2020 curriculum.
