REVISED NOTIFICATION REGARDING SECOND EXAMINATION OF SEMESTER III-IV STUDENTS OF SESSION 2025-2026

Examination Committee in its meeting held on 30.07.2026 reviewed the provisions for students of Semester III-IV of Session 2025-2026 with respect to Second Examination. The revised provisions are as follows:

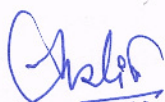
1. It was decided to permit the UG Semester III-IV students of Session 2025-2026 to make their own choice of paper(s) from among the papers of subject/subjects in which they have failed. Consequently, it was decided that students shall be permitted to appear in Second Examination in those paper(s) which they have chosen. Second Examination fee shall also be charged accordingly.
2. It was also decided to permit all the "pass" students of UG Semester III-IV of Session 2025-2026 to appear in Second Examination in one or more papers of Semester III and/or Semester IV of one subject only. However, it was pointed out that the result of second examination shall be treated as final result and pass/promotion/fail of a student shall be decided based on the result of second examination. Therefore, second examination shall not be treated as improvement examination.
3. It was also decided that if a student who has passed Semester III-IV fills the second examination form of one or more papers of one subject and is unable to appear in the said examinations, they shall be marked absent and pass/promotion/fail of such students shall be decided accordingly. This is because the result of second examination is being treated as final result.
4. All students of Semester III-IV of Session 2025-2026 who pass in all subjects after the second examination of Semester III-IV shall be placed in the "pass" category and shall be promoted to Semester V-VI of Session 2026-2027.
5. All students of Semester III-IV of Session 2025-2026 who are placed in the "fail" category after second examination shall be conditionally promoted to Semester V-VI of Session 2026-2027. However, they will have to appear in the special examination which will be conducted after Semester VI examination of Session 2026-2027 and pass in all failed subjects of Semester III-IV of Session 2025-2026 to become eligible for award of degree in the Session 2026-2027 provided they have passed Semester V-VI in the session 2026-2027.
6. Those students who are unable to pass in any of the failed subjects of Semester III-IV of Session 2025-2026 in the Special Examination of Session 2026-2027 will have to appear in the Special Examination of Session 2027-2028 and so on till they pass in all failed subjects.

- . It was further decided that in order to become eligible for award of degree, all students of B.A., B.Sc. and B.Com. who took admission in Semester I in the Session 2024-2025 (old system) shall have to pass Semester I-II, Semester III-IV and Semester V-VI and all add-on courses (AEC/SEC/SSSEC) from Semester I to VI within six years from the year of their enrolment in the college. There is no provision for any extension in this regard.
8. All students of Semester III-IV of Session 2025-2026 who have failed and are being promoted to Semester V-VI of Session 2026-2027 shall be permitted to take admission in Semester V-VI as regular students by paying the relevant course fee.
9. If students of Semester V-VI of Session 2026-2027 fail in one or both subjects opted by them in Semester V-VI, they will be permitted to appear in Special Examination in all papers of their choice of both subjects opted by them in Semester V-VI Session 2026-2027.
10. All students shall have to fill the second/special online examination form and deposit relevant examination fee in order to be permitted to appear in any of the above examinations.

It was further resolved that since this is a special situation which has to be handled by the College in the best interest of the students, therefore these decisions taken above shall not be treated as precedence and no application shall be entertained in this regard at any later stage.

NOTE: In the light of the above resolutions, the **SECOND EXAMINATION FORM** of UG Semester III-IV of Session 2025-2026 will be opened once again as follows:

- From 01.08.2026 (10:00 AM) to 05.08.2026 (05:00 PM) - Without late fee
- From 07.08.2026 (10:00 AM) to 09.08.2026 (05:00 PM) - With late fee
- Second Examination will commence from 10.08.2026, time table will be announced soon
