NOTIFICATION

A combined meeting of the College Examination Committee and Heads & Coordinators Committee was held on Monday July 13th, 2026 at 12:30 PM in the Conference Hall of the Administrative block in which many pressing issues were discussed. One of the issues under serious consideration was the fate of all students of UG Semester III-IV of Session 2025-2026 who have been placed in the "failed" category. It was discussed that in the normal course such students would have to take admission as Ex-students in the old system in Session 2026-2027 and as such they will have a completely different syllabi, different format of question paper, different duration of examinations, etc. as compared to the regular UG Semester III-IV students of Session 2026-2027 studying under the NEP-2020 provisions. It was highlighted that under such circumstances it will be very difficult to simultaneously conduct two completely different academic programs (old system and NEP-2020 provisions) in the same session. It was further pointed out that such Ex-students who pass UG Semester III-IV in Session 2026-2027 will be permitted to take admission as regular students in the old system in Semester V-VI in Session 2027-2028. In such situation, all their theory and practical classes will have to be conducted separately along with the conduct of Tutorial and End-Semester examinations. This will also be a huge problem because in the Session 2027-2028, there will also be regular students of the new system under NEP-2020 provisions and it will be extremely difficult to conduct all classes and conduct all examinations of two completely different systems which are very different from each other.

The said matter was discussed in detail and keeping the above situation in mind, it was unanimously decided that:

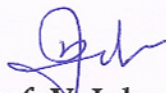
1. It was decided to permit all UG Semester III-IV students of Session 2025-2026 to appear in Second Examination of all theory papers and/or practical examinations of all subjects in which they have failed that is whether they have failed in one subject or two subjects or three subjects. In this way such students will have an opportunity to pass in all failed subjects and take routine admission in Semester V-VI of Session 2026-2027.
2. All students of Semester III-IV of Session 2025-2026 who are unable to pass in one subject or two subjects or three subjects and have been placed in the failed category after the declaration of result of the above second examination will be promoted conditionally to Semester V-VI of Session 2026-2027. However, they will have to appear in the special examination which will be conducted after declaration of Semester VI result of Session 2026-2027 and pass in all failed papers of Semester III-IV to become eligible for award of degree in the Session 2026-2027.
3. Those students who are unable to pass in any of the failed subjects of Semester III-IV of Session 2025-2026 in the Special Examination of Session 2026-2027 will have to re-appear in the Special Examination of Session 2027-2028 and so on till they pass in all subjects of all Semesters.

P.T.O.

Each student of B.A., B.Sc. and B.Com. Who took admission in Semester I in the Session 2024-2025 (old system) will get up to a maximum of six years from the year of enrolment in the College for passing in all examinations and to become eligible for award of degree.

5. All students of Semester III-IV of Session 2025-2026 who have failed and are being promoted conditionally to Semester V-VI of Session 2026-2027 shall be permitted to take admission in Semester V-VI as regular student by paying the relevant course fee.
6. Such students will also be permitted to appear in Special Examination in all papers of all subjects which they have opted in Semester V-VI of Session 2026-2027.
7. It was further decided that in order to become eligible for award of degree, a student will have to pass in all subjects from Semester I to VI and all add-on courses from Semester I to VI.
8. All students shall have to fill the second/special online examination form and deposit relevant examination fee in order to be permitted to appear in any of the above examinations.

It was further resolved that since this is a special situation which has to be handled by the College in the best interest of the students, therefore these decisions taken above shall not be treated as precedence and no application shall be entertained in this regard at any later stage.

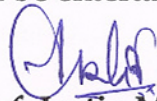

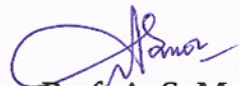
